Notice to Water Users 2021 Dry Year Water Pool

March 12, 2021

On March 10, 2021 the District Board authorized the District to offer up to 10,000 acre-feet of remaining Dry Year Water Supply as an additional response to our local water needs. The **cost of this water supply is \$650.00 per acre-foot** and can be (1) scheduled for delivery within the District for this year, (2) carried over to 2022 or (3) banked for future use. Please note, that if your intent is to carryover this supply to 2022 there is a risk that this supply may be lost in the event San Luis Reservoir spills. The District will work with you to mitigate this risk should such an event occur. Water banked for future use will be subject to our standard Landowner Banking Agreement policies.

This water supply is restricted to use within the District and is only available to water users within the District that are in good standing and have an operable District turnout. This water supply is not transferable.

Water users may request any quantity of water up to 10,000 acre-feet.

If you are interested in participating in this water program, please complete the attached subscription form and **return to the District Dispatch office** as soon as possible.

Oversubscription for the 2021 Dry Year Water Pool may result in either equal allocation between all landowners who subscribed or allocated on a first come first serve basis. Therefore, it is in your best interest to submit your form directly to the Dispatch office such that it can be time stamped.

Subscription forms will be accepted until Friday, **April 2, 2020** at 5:00pm.

Once subscription forms are submitted and approved, participating water users will receive a Notice of Allocation.

Landowners who receive an allocation of water under this dry year program **must submit full payment to the District within 10-business days of allocation.** Your allocation will be forfeited if payment is not received within this timeframe.
